## EXHIBITOR INFORMATION

**WHO:** Sponsored by the Greater Marathon Chamber of Commerce and the Organized Fishermen of Florida.

**WHERE:** Marathon Community Park, MM 49, U.S. 1 Ocean side, located in the center of Marathon.

**WHEN:** Saturday, March 13, 10 am - 9 pm and Sunday, March 14, 10 am to 5 pm.  
Setup: Friday, March 12, beginning at noon to 6:00 pm, Saturday, March 13, 7:30 – 9:00am.

Breakdown: Sunday, March 14, 5:30 pm or Monday, March 15, all day. **Due to the new location, tents will have to be secured without stakes and only a controlled number of motorized vehicles will be permitted on the field at any time.** We will have a limited number of golf carts available to assist you or bring a hand cart, but please plan ahead so set-up will go smoothly.

**HOW:** Simply fill in the reverse side of this Contract form, **sign both sides**, enclose your check and mail. The Marathon Chamber has full and final discretion as to the exact location of each Exhibitor's booth. In addition, the Marathon Chamber of Commerce has complete authority to accept or reject any Exhibitor. All applications must be submitted with payment. Please complete all items on the reverse side. Spaces will be assigned on a first come, first serve basis. You will be assigned a number when your application **and payment have been received.**

**SALES TAX:** The State of Florida requires sales tax to be paid on all goods sold at this festival. Please provide your certificate number on the reverse side. If you will not have goods for sale at the festival, please enter N/A instead of your tax number.

**PARKING:** A Vendor parking area and pass will be provided. **Due to limited parking in our new location, only one parking pass will be issued to each vendor.**

**RULES:** **ABSOLUTELY NO PETS of any type WILL BE ALLOWED.**

City regulations: NO OVERNIGHT PARKING WILL BE PERMITTED ON SITE.

Regulations must be observed and none of the sponsors, including the Greater Marathon Chamber of Commerce and the Organized Fishermen of Florida and its employees, officers, members and directors, can be responsible for any loss, injury or damage sustained by an Exhibitor, its employees or guests.

The Exhibitor agrees to indemnify and hold harmless all sponsors. Exhibitors causing damage to the city park premises or property shall be liable for the cost of repair and related expenses necessary to recover said expenses.
